Refundable Deposit to Get Started

Fund a \$200 deposit through your debit or prepaid card to open your Credit Builder Card with a credit line of \$200. Just like your apartment rental deposit isn't used to pay your monthly rent, your card deposit is not available to pay for purchases you make with the card.
